

**NOTIFICATION**  
**State Medical & Dental P.G. Seats Allotments-2020 (Round 2, on-line)**

The allotment process (Round 2) to various PG Medical and Dental courses, for Rajasthan State registered candidates, will be carried out **on-line** (due to prevalent pandemic Covid-19 situation in the State of Rajasthan) as per the schedule given below:

**The candidates must read the following instructions/information carefully:**

For verification, candidate belonging to NRI category **must present personally along with relevant original documents** at Govt. Dental College, Shastri Nagar, Jaipur at 9.00 am.

**Choice filling (round 2)**

**Important: It is essential to fill Fresh Choices for round 2. Choices filled earlier for round 1 are not valid for this on-line round 2 (All the choices filled for round 1 shall be treated as cancelled / null and void for round 2 counseling).**

If a candidate does not submit his/her choice by the last date of filling the choices i.e. by 21.07.2020, 2.00 pm, he/she will lose chance of participation in the on-line allotment process. Candidates must fill their choices, very carefully, based on the seat matrix and corresponding fee structure, as the choices filled shall be final for on-line allotments.

**Round 1 allotted and joined candidates who are willing to upgrade in round 2 must fill choices for round 2, afresh.**

Any candidate opting the seat that is permitted but not recognized by the MCI, New Delhi will not be allowed to claim for any change on this ground, except during subsequent round of allotment, if any, depending upon his/her merit and as per preference only. The candidates are required to visit website of Medical Council of India, regarding Permission/Recognition/Current Status of Post graduate seats in Govt./Private Medical Colleges of Rajasthan. The admission board will not be responsible for the consequences, if any.

**Following candidates are eligible to participate in Round 2:**

Candidates allotted a college in Round 1 but did not report  
Candidates reported in the college allotted in Round 1 but resigned  
Candidates not allotted a college in Round 1 (Choice not available)  
Candidates who filled Part-1 and Part-2 and deposited registration fee

**Following candidates are NOT eligible to participate in Round 2:**

Candidates allotted and joined a college through any other counseling including All India PG counseling  
Candidates registered for State PG Admissions 2020 but do not now fill choices, afresh  
Candidates with incomplete information form filling / non-deposition of registration fee

**Forfeiture of fee / Permissibility to students to participate in Round 2 counseling**

All candidates willing to participate must deposit, if not deposited earlier, on-line INR 25,000/- (INR 12,500 for SC/ST/OBC/MBC) for allotment in Govt. Medical Colleges and Govt. Societies colleges (Jhalawar) / RUHS Medical College and INR 2,00,000/- (for allotment in Private Medical colleges) **by 21.07.2020, 12.00 noon**, failing which they will not be considered for admission on a seat in a college in Round 2.

In Round 1, those candidates who deposited only INR 25,000/- or 12,500/- (for SC/ST/OBC/MBC) as the case may be and who filled choices of Govt. colleges only and now wish to opt for private colleges also (along with Govt. colleges) are required to deposit the difference amount of INR 175000 or INR 187500 (as the case may be) on-line **by 21.07.2020, 12.00 noon**, failing which they will not be considered for admission on a seat in a private college.

**Submission of original documents**

All candidates who get allotment on a seat in round 2 on-line counseling (as well as who reported through on-line reporting mode at the allotted college and not upgraded in round 2) must report physically and join at the allotted college as notified in the allotment letter and also deposit all the original documents and undertaking (as given in the instruction booklet available at the website) and accepted resignation from the institution he/she is pursuing studies at present. Failure to do so will result in disqualification for admission.

**Conditions relating to bond etc. (applicable for Govt. colleges)**

At the time of reporting, the selected candidates under both the All India and State Quota for the PG courses (for the academic session 2020-21) will have to submit a surety bond of Rs. 5.00 lacs (Rupees five lacs) in favour of Principal of the allotted college. At the time of final joining, a separate Bank Guarantee for Rs. 1.5 lacs and Bond for Rs. 3.5 lacs is to be submitted (surety bond of Rs. 5 lacs submitted earlier will be returned).

The students so selected under both the All India and State Quota for the PG courses (for the academic session 2020-21) in medical fraternity will have to fill a bond amounting to Rs. 25 lacs (Rupees twenty five lacs) for a Degree course and Rs. 5 lacs (Rupees five lacs) for a Diploma course, for commitment to serve the State Government of Rajasthan for a period of Five (5) years (bond format available at the website).

As per Government order dated 31.03.2017, 05.04.2017 and 19.05.2020 Senior Demonstrators working in non-clinical and para-clinical subjects will be given priority (in the same Department in which they are working) as per merit of NEET PG-2020.

**Conditions relating to bond etc. (applicable for private colleges)**

At the time of reporting, the selected candidates will have to submit a bond / bank guarantee as applicable. For details, refer website of respective private colleges / contact college office.

**Allotments**

The allotment of the subject and college shall be made strictly on the basis of merit cum preference as per the reservation roster and in accordance with the rules laid down by MCI/DCI/Hon'ble Supreme Court of India / Hon'ble High Court, Rajasthan / Government of Rajasthan and RUHS.

The norms of reservation of the State Government of Rajasthan will be applicable only for bonafide candidates of the State of Rajasthan. They will have to produce a valid certificate as per State Govt. rules.

No individual information shall be sent to the candidates.

All the allotment procedures will be provisional and will be subject to the Final Decisions of Hon'ble Supreme Court of India/ Hon'ble High Court of Rajasthan in various related matters.

The decision of the PG Admission Board-2020 will be final and binding on all the candidates. In case of any dispute, the area of jurisdiction will be Hon'ble Rajasthan High Court only.

The candidates are advised to read the notification, instruction booklet, etc. given on the website, very carefully and also visit the websites regularly.
